GLENMORISTON CHILD PROTECTION POLICY

Glenmoriston Shooting Ground aims to provide all members, children, young people and their families with a clear policy ensuring that children and young people are protected from harm when visiting the shooting ground.

Glenmoriston Shooting Ground supports and follows the child protection policy guidelines of The Child Protection in Sport Unit, sports coach UK, and the NSPCC.

This policy is also intended for use with vulnerable adults.

Glenmoriston Shooting Ground has adopted the Child Protection in Sport Unit's social network, photography and filming consent policies. Copies of these are available from the Shooting Ground Office and the Child Protection Officer.

In the event that our Child Protection Officer has any concerns of abuse regarding a child or young person, Glenmoriston Shooting Ground reserves the right to report this to the necessary authorities.

Individual children and young people must be attended at all times by a parent, guardian, carer, or designated responsible adult.

The responsible person must provide Glenmoriston Shooting Ground with any health issues or concerns of the child (children) or young adult(s) they are responsible for.

Groups of children or young people from schools, youth clubs and other institutions must provide their own responsible staff including their own

Child Protection Officer, who will be briefed prior to their attendance on matters of safety and general shooting ground rules. Their Child Protection Officer must supply Glenmoriston Shooting Ground with individual records of those attending, including any health issues, concerns, and emergency contact telephone numbers.

Glenmoriston Shooting Ground's staff, coaches, and committee members are advised not to communicate by social media to any child or young person, without including the parent, guardian, or carer, and one other member of staff, coach, or committee member.

All members of Glenmoriston Shooting Ground's staff, coaches, and committee members are advised not to become friends with children and young persons on social media without informing the parent, guardian, or carer, and declaring this to the Chairman, or Secretary, and the Child Protection Officer.

Glenmoriston Shooting Ground reserves the right to stop any child or young person shooting if it considers that a danger exists to that person or any others using the shooting ground.
